

CONCRETE STAMPING MAT RENTAL TERMS AND CONDITIONS

This document is a rental contract. Please familiarize yourself with its contents so there will be no misunderstandings as to your obligations. The words YOU and YOURS mean the persons who sign this rental contract. WE, OUR and DEALER refer to the company as indicated in the "Rented From" entry above. The bullet points below contain important terms and conditions including dealer's disclaimer from all liability for injury or damage and details of renter's obligations for rental and other charges and responsibilities to care for and return items rented.

1. **INSPECTION.** Customer acknowledges that he has had an opportunity to personally inspect the equipment, and finds it suitable for his needs and in good condition and that he understands its proper use.
2. **HOLD HARMLESS AGREEMENT.** Customer agrees to assume the risk of, and hold Dealer harmless for, property damage and personal injuries caused by the equipment and/or arising out of Customer's negligence.
3. **SUBLEASING EQUIPMENT.** Under no circumstances may Customer sublease the equipment he is renting and for which he is responsible.
4. **TIME OF RETURN/CHARGES AND PAYMENTS.** Customer is responsible for rental charges from the first time the item is "Rented Out" until it is "Returned". Tool sets are rented at the rate of \$250/day for each day they are in Customer's possession. If Customer rents a tool set before 12 Noon on any given day, he must return it before 12 Noon on the day the tool set is brought back. If returned after 12 Noon, an additional day's rental fee will be charged. If Customer rents a tool set after 12 Noon on any given day, he can return it at any time from 7:30 AM to 4 PM on the day the tool set is brought back. If equipment is rented on a Saturday it can be returned the following week without Sunday being counted as a day the equipment is out.
5. **LATE CHARGES.** Each day the rental is not returned will incur a \$250/day charge.
6. **SECURITY DEPOSITS.** Customer agrees to pay a refundable \$250 rental deposit. The rental deposit will be refunded to Customer when equipment is returned according to the terms of this contract. The equipment deposit will only be charged to the customer in the event they fail to return the equipment.
7. **CARE.** Customer agrees to return the equipment in the same condition as when picked up. Meaning, powder release agent will be, at minimum, swept or air blown off of the equipment and any residual concrete will be cleaned entirely off any and all equipment surfaces. **If the equipment is returned without having first been cleaned, Customer agrees to pay a \$100 cleaning fee to Dealer.**
8. **DISCLAIMER OF MANUFACTURE.** Customer agrees that Dealer is neither manufacturer of the rented goods nor an agent of the manufacturer.
9. **TITLE.** This agreement is not a contract of sale. Title to the goods is and shall remain in Dealer's name.
